SCOPE OF WORK FOR CARPET TILES TO BE PROCURED

PURPOSE

USAID/RDMA is seeking to procure new office carpet to replace the current carpet. The carpet tiles are required for certain areas of the office space. The areas that are to be carpeted are included in "STATEMENT OF WORK". The carpet tiles are custom designed carpet that meets USAID/RDMA design requirements. The carpet is required to be manufactured and delivered as determined by USAID after award of the contract or such later date as agreed to between USAID/RDMA and the offeror, in order to comply with the USAID schedule. The contractor will be responsible for the supply of carpet tiles at Athenee Tower for USAID on level 31. The materials supplied shall be as specified below with LEED certification making up a majority of the selection criteria for award of this contract.

STATEMENT OF WORK

Description of Carpet Tiles:

- a. Surface Content: 100% nylon, 22 oz.
- b. Size: .5m x .5m
- c. Backing: Recycled Materials
- d. Quantity:
 - i. 31st Floor – 1,263 sqm.

The suppliers should only use these measurements as a guide. Floor Plans will be provided upon request.

Execution of Work:

Carpet tiles must be available on a mutually agreed to schedule for installation either in 2015 or 2016 per notice of approval of the color and/or design by USAID and issuance of a notice to proceed.
