Materials created by the K-12 OER Collaborative will include all of the useful elements from commercial textbook companies as well as all of the advantages of openly-licensed materials, with significant cost savings. By sharing and adapting OER, content acquisition costs can be cut dramatically, allowing schools to make better use of available resources, shifting funds to professional learning or technology purchases as needed.

LEAs that make advance market commitments to enable the development of K-12 OER Collaborative materials will contribute a percentage of the savings realized by adopting the open materials. With this advance market commitment, LEA's will also be given membership in the Collaborative and will be able to directly influence the work of the project as it moves forward.
