

# FFP Summary of Changes for FY 2017 APS

#### **Overall Summary**

The draft APS has been significantly revised with the intent of making it more user-friendly and more direct about the types of information FFP wants to see from applicants. The APS has been updated to cover more market strengthening and complementary activities. FFP is introducing new mandatory indicators for longer-term programming, as well as a revised format for narrative reporting, while also seeking to clarify some of the FFPMIS data entry requirements.

All detailed changes are listed by the section that they fall under in the draft APS:

#### I. FUNDING OPPORTUNITY DESCRIPTION

- 1. Added language under program objectives to link to the FFP Strategy.
- 2. Added "protracted crisis" to list of response types.
- 3. Added language on international procurement and new source/origin policy.
- 4. Added "market strengthening" as a food security modality.
- 5. Changed name of category Complementary Services to Complementary Activities.
- 6. Added reference to OFDA Guidelines for Proposals technical chapters related to complementary activities.
- 7. Added categories of potential complementary activities under the 20% threshold:
  - a. WASH
  - b. Coordination Support
  - c. Social Cohesion

- 8. Gender and conflict sensitivity moved to sub-categories under Participants.
- 9. Stronger language to emphasize targeting based on need, not status alone.
- 10. Changed "Management and Logistics" section to "Operations and Logistics", and moved operational details out of Project Design and Description into new Operations and Logistics category.
- 11. Commodity safety language re-written in entirety.
- 12. Narrative application sections substantially rewritten.
- 13. Moved M&E out of application into annex.
- 14. Added risk assessment annex; provided link to Remote Cash Project site for example.
- 15. Added language requiring baselines and evaluations except in the event of rapid on-set disasters and programs less than 10 months.
- 16. Added requirement to utilize Food Consumption Score indicator in baselines, monitoring and evaluations.
- 17. Environmental requirements for emergency projects updated.
- 18. Revised market section to have more modality neutral language, except where specifics are needed.
- 19. Added language on storage capacity and disincentives to production.
- 20. Added file naming convention for consistency
